

**RESOLUTION 18-04**

**A RESOLUTION AMENDING THE BUDGET OF THE VILLAGE COMMUNITY DEVELOPMENT DISTRICT 4 FOR FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018 FOR THE FISCAL YEAR 2016-17 CARRYFORWARD REQUESTS**

**WHEREAS**, on September 9, 2016 the Board adopted the Fiscal Year 2016-17 Budget that included \$823,568 for plant replacement, tree maintenance, and road mill & overlay projects; and,

**WHEREAS**, on November 18, 2016, the Board amended the Fiscal Year 2016-17 Budget in Resolution 17-03 to carryforward \$11,790 for plant replacements from Fiscal Year 2015-16; and,

**WHEREAS**, a carryforward from Fiscal Year 2016-17 in the amount of \$429,781 has been requested to provide funds for plant replacement, tree maintenance, and road mill & overlay projects in Fiscal Year 2017-18; and,

**WHEREAS**, the request to carryforward these projects and re-appropriate in the Fiscal Year 2017-18 Budget has been reviewed and approved by the District Manager.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE VILLAGE COMMUNITY DEVELOPMENT DISTRICT 4 THAT THE FISCAL YEAR 2017-18 BUDGET BE AMENDED AS FOLLOWS:**


