AMENITY AUTHORITY COMMITTEE (AAC)

As a result of an inter-local agreement between Village Center Community Development District, Village Community Development District No. 1, Village Community Development District No. 2, Village Community Development District No. 3, Village Community Development District No. 4 and the Town of Lady Lake, an Amenity Authority Committee has been established.

The Amenity Authority Committee will be governed by a Board of Directors comprised of six (6) members representing each of the following six (6) geographic regions:

- Village Center Community Development District
- Village Community Development District No. 1
- Village Community Development District No. 2
- Village Community Development District No. 3
- Village Community Development District No. 4
- Town of Lady Lake

The Amenity Authority Committee shall advise Village Center Community Development District on matters relating to Amenity Facilities, Amenity Fees and services related to Amenity Facilities and Amenity Fees.
