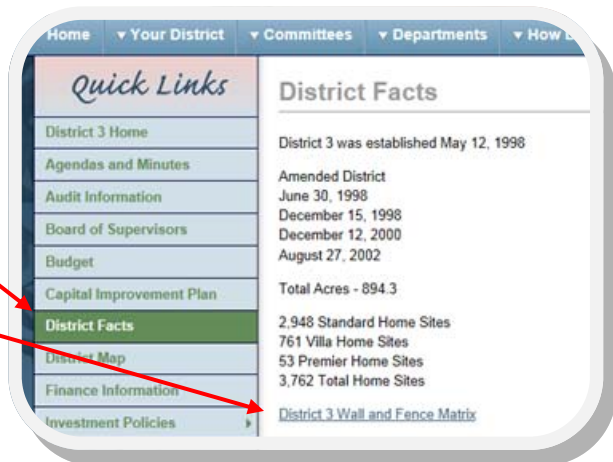
## Wall and Fence Matrices
