SUBJECT: **Adopt Resolution 2022-01: FY20-21 YE Final Budget Adjustments**

ISSUE:

Adoption of Resolution 2022-01 amending the Fiscal Year 2020-21 Budget.

ANALYSIS/INFORMATION:

The Village Community Development District No. 10 Board of Supervisors adopted the Fiscal Year 2020-21 Budget at a public meeting held on September 3, 2020.

As is customary at the end of each fiscal year, the financial records are reviewed for any budget adjustments. The governing body of each special district at any time within a fiscal year or up to 60 days following the end of the fiscal year may amend a budget for that year per State Statutes. This resolution will ensure that the actual expenditures are within budget appropriations and reduce the number of variances during the audit process.

Attached is Resolution 2022-01 to amend the District 10 Fiscal Year 2020-21 Budget. The 2012 and 2014 Debt Service funds are being amended for the additional prepayments. The 2012 and 2014 Capital Project funds for District 10 need to be amended to cover the transfer of excess funds.

**A RESOLUTION AMENDING THE VILLAGE


