

ORDINANCE NO. O2019-7

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF WILDWOOD, FLORIDA, AMENDING THE BOUNDARIES OF THE VILLAGES COMMUNITY DEVELOPMENT DISTRICT NO. 12 PURSUANT TO FLORIDA STATUTE 190.046; ENCOMPASSING PORTIONS OF THE LAND IN SECTIONS 20, 21, 28, 29, 31, 32, 33, AND 34 OF TOWNSHIP 19 SOUTH, RANGE 23 EAST, SUMTER COUNTY, FLORIDA, AND RATIFYING AND CONSENTING TO THE POWERS AUTHORIZED IN SECTION 190.012(1) AND 190.012(2) FLORIDA STATUTES; PROVIDING FOR THE POWERS OF THE DISTRICT; PROVIDING FOR THE REPEAL OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of The City of Wildwood adopted Ordinance Number O2011-09 on September 13, 2011;

WHEREAS, Ordinance Number O2011-09 established The Wildwood Springs Development District;

WHEREAS, the City Commission of The City of Wildwood adopted Ordinance Number O2016-27 on July 11, 2016, amending Ordinance Number O2011-09;

WHEREAS, Ordinance Number O2016-27 approved a petition to the City of Wildwood requesting the legal description included as Exhibit "A" to Ordinance O2011-09 be struck in its entirety and replaced with a new Exhibit "A" consisting of a new map and legal description reflecting a net reduction in the size of the District such that the resulting District totaled 699.02 acres and that the name of the Wildwood Springs Development District be changed to "Village Community Development District No. 12" (the "District");

WHEREAS, Ordinance Number O2017-44 approved a petition to the City of Wildwood requesting the legal description included as Exhibit "A" to Ordinance O2016-27 be struck in its entirety and replaced with a new Exhibit "A" consisting of a new map and legal description reflecting an increase in the size of the District by 491.4 acres, such that the resulting District totaled 1,190.4 acres, more or less;

WHEREAS, Ordinance Number O2018-3 approved a petition to the City of Wildwood requesting the legal description included as Exhibit "A" to Ordinance O2017-44 be struck in its entirety and replaced with a new Exhibit "A" consisting of a new map and legal description reflecting an increase in the size of the District by 299.6 acres, such that the resulting District totaled 1,490.0 acres, more or less;

WHEREAS, Ordinance Number O2018-57 approved a petition to the City of Wildwood requesting the legal description included as Exhibit "A" to Ordinance O2018-3 be struck in its entirety and replaced with a new Exhibit "A" consisting of a new map and legal description reflecting an increase in the size of the District by 3.6 acres, such that the resulting District totaled 1,486.4 acres, more or less;

WHEREAS, the District has approved a petition to the City of Wildwood requesting that the legal description included in Exhibit "A" to Ordinance O2018-57 be amended to reflect an increase in the size of the District by 5.3 acres and a decrease in the size of the District by 8.8 acres, resulting in a net decrease of 3.5 acres, such that the resulting District will total 1,482.9 acres, more or less;

WHEREAS, the District has filed a petition to the City of Wildwood "PETITION TO AMEND THE BOUNDARIES OF VILLAGE COMMUNITY DEVELOPMENT DISTRICT NO. 12 PURSUANT TO FLORIDA STATUTES 190.046;"

WHEREAS, in the Petition, the District requests that the City pass an ordinance amending Ordinance O2019-7, to reflect the new legal description and amended boundary of the District, and;

NOW, THEREFORE, BE IT ORDAINED by the City Commission of The City of Wildwood, Florida, that Ordinance Number O2019-7 is hereby amended as follows:

SECTION 1: *Petition.* The "Petition to Amend the Boundaries of Village Community Development District No. 12 Pursuant to Florida Statutes 190.046," as submitted to the City of Wildwood Commissioners, is hereby GRANTED.

SECTION 2: *Modification of Map and Legal Description.* Exhibit A to Ordinance Number O2018-57 is hereby stricken in its entirety and replaced by the map and legal description attached hereto and incorporated herein as "Exhibit A."

SECTION 3: *Ratification and Consent.* The City Commission of The City of Wildwood, Florida, ratifies and consents to the special powers authorized in Section 190.012(1) and 190.012(2) Florida Statutes as requested by the petitioner.

SECTION 4: *Severability.* If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the invalidity shall not affect other provisions or applications of the Ordinance which can be given the effect without the invalid provision or application, and to this end, the provision of this ordinance are declared severable.

SECTION 5. *Effective Date.* This Ordinance shall take effect upon adoption.

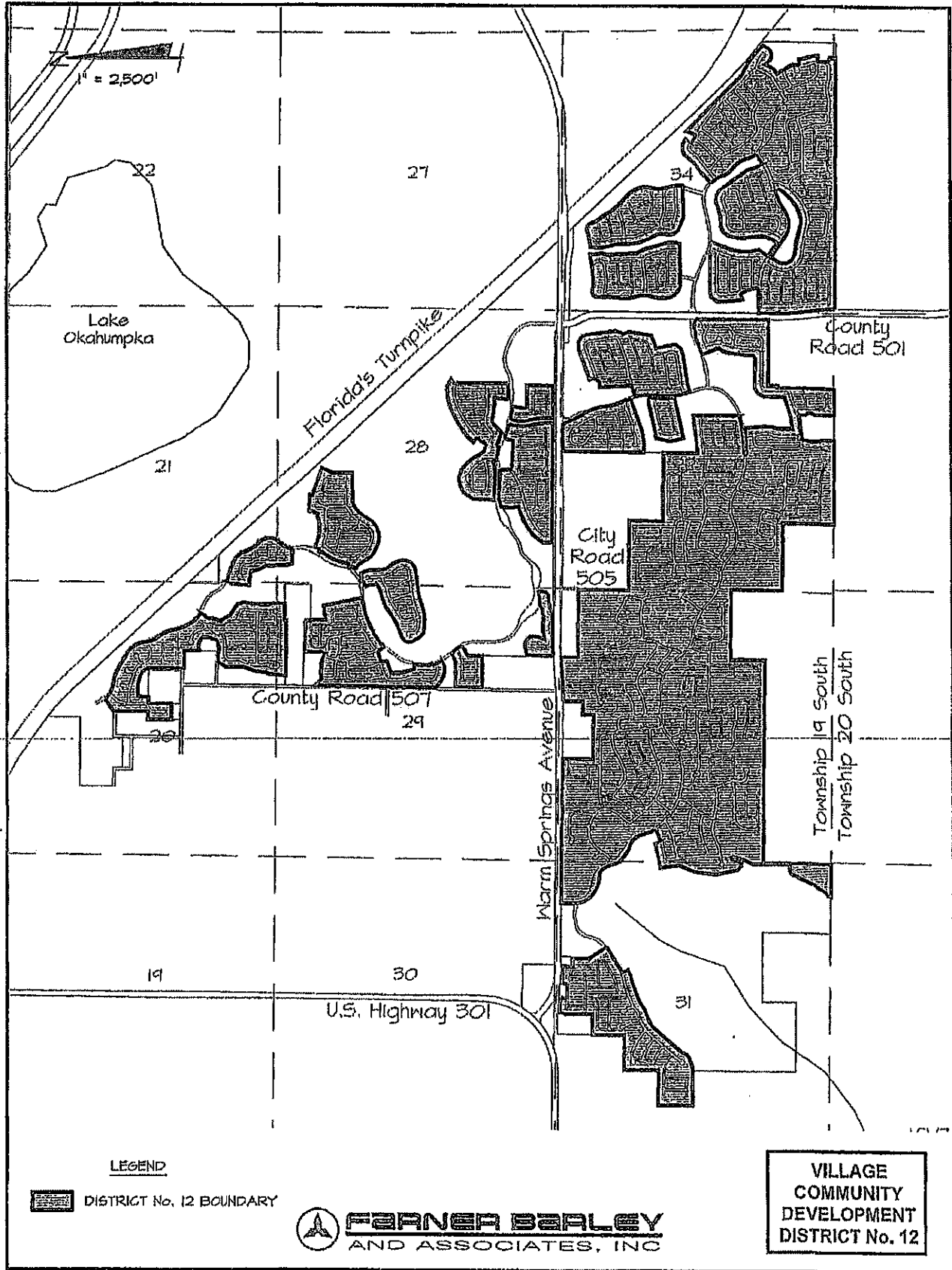
