Red and Grey Fox Executive Courses

Red and Grey Fox Executive Golf courses are closed for rest and rehabilitation until further notice.

Chula Vista Executive Course

De La Vista Golf course is closed until further notice for its bunker sand replenishment project.

Sarasota Golf course will be closing from **May 15 to May 23** for aerification and tee renovation.

Briarwood Golf course will be closing **May 14 to May 18** for aerification.

HOW MUCH IS ENOUGH?

Have you wondered if your water bill and water consumption could be less, but not sure what it could drop to? The tables to the right are based on guidelines from SWFWMD and the University of Florida showing average monthly consumption based on the typical lot size for the types of homes in The Villages. With active management, your water bill could be significantly less, especially during the winter and the summer wet season.

To calculate usage for your home if you do not have a standard size home or lot, use the method shown below.

If you live north of CR 466 with a single water meter

Your home is: Your water usage should average this per month:

Patio	5,500 gallons
Courtyard	6,000 gallons
Ranch	9,800 gallons
Designer	9,700 gallons
Premier	20,200 gallons



If you live south of CR 466 or south of SR44 with an outdoor and indoor meter

Your home is: Your water usage should average this per month:

Patio	3,000 gallons	+2,700 gallons*
Courtyard	3,800 gallons	+2,700 gallons*

Premier	17,700 gallons	+2,700 gallons*

*2,700 gallons monthly average represents indoor usage for a household with two occupants, regardless of home size.

Village Community Development Districts 1 – 11

If you live in Districts 1 – 11 located in Sumter County, Marion County or Fruitland Park portions of The Villages, there will be normal residential sanitation collection on Monday, May 27, 2024.

If you live in Village Community Development District 12, the Village of DeLuna and Hammock at Fenney, and District 15, there will be no sanitation schedule change due to the holiday.

Village Community Development District 13 (excluding Villages of DeLuna and Hammock at Fenney) and District 14

If you live in Village Community District 13 (excluding Village of DeLuna and Hammock at Fenney) and District 14, there will be no residential sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Thursday, May 30, 2024.

If you live in the **Town of Lady portion of The Villages**, there will be no residential sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Thursday, May 30, 2024.

If you live in the **Lake County portion of The Villages** (not including VCDD No. 11 and 14), there will be no sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Tuesday, May 28, 2024. All collection days for the week will be moved to the next day.

If you live in the **Middleton Community Development District**, there will be no sanitation schedule change due to the holiday.
