

Financial Statement Summary As of June 30, 2024

Special Assessment Revenue Bonds, Series 2023 in the amount of \$155,490,000 were issued for Phase I in July 2023. General operating costs have an amended budget of \$3,225,000 for the current year that will be reimbursed by the Developer until such time that the maintenance assessments are received through the county taxes collections to the homeowners.

Revenues

Year-to-Date (YTD) Revenues are \$1,926,000.

- Contributions from Developer total \$1,922,000
- Interest income of \$4,000 has been received year to date.

Expenses and Other Changes

Year-to-Date (YTD) Expenses of \$1,922,000 have been recorded to date.

- Management and Other Professional services include legal fees. Total costs year to date are \$99,000.
- Building, Landscape and Other Maintenance Expenses total \$1,813,000 year to date.
- Other expenses include insurance expenses and total under \$9,000 year to date.

Change in Unrestricted Net Position

The year-to-date change in net position is \$4,000.
